# Conditions of participation

The provisions under which participation in 'Credit Expo Belgium' (hereinafter referred to as: the event) can take place are set out in the following conditions of participation.

## Organisation

## Venue and time

The event will be held at De Montil in Affligem on Thursday 27 March 2025.

## Opening hours

The event will be open to visitors from 09:00 to 18:00. For event partners, the event will be open from 08.00 hrs.

## Stand construction

The event partner's stand will be delivered completely by the organiser (= wall with printing and possibly TV screen, table and chairs, electricity and wifi). On 27 March between 08.00 and 09.00, the event partner's laptop can be connected to the screen by them (for demos and presentations). It is allowed to further decorate the stand with additional own marketing material (e.g. roll-up banner or beach flag), but no large folding stand. Own stand construction by the event partners is not allowed.

## Special activities

Special activities at the meeting points, such as performances with sound and image, can only take place if written permission has been requested and obtained from the organisers no later than 30 days before the start of the event. One of the conditions for granting permission is that the activity must be situated in such a way that visitors are not inconvenienced.

## Event partners

The organisations participating in the event are economically active in the credit management market or related financial services. The organisation reserves the right to refuse participants without having to account for this.

## Access policy

Credit Expo can only be attended free of charge by professionals who

are involved in the deployment of credit and cash management solutions for the benefit of their own organisations as policy-makers, buyers or end-users. Individuals working for or on behalf of a supplier, intermediary or consultancy focused on credit managers are not part of the visitor target group and do not have free access. Each partner will receive a unique registration link to distribute to prospects and/or relations belonging to the target group at their own discretion. The organisation reserves the right at all times to reject registrations (including those received via partners) if it appears that the access policy is not being applied in accordance with the rules.

## Programme

Only products and services can be presented at the event that, in the opinion of the organisation, are in line with the aim of the event to offer the public the broadest possible overview of the Belgian market for credit management and related aspects. This at the discretion of the organisation.

## Cancellation

Cancellation of confirmed participation by the event partner is not possible due to the one-off nature of the event.

## Reservation due to changes

The organisers reserve the right to change the dates and times of the event due to special circumstances beyond their control, and if the organisers so require, or to cancel the event, without the participant being able to make any claims against the organisers for compensation for any damage, in whatever form or from whatever cause. If the live event cannot take place due to corona measures, the organisation reserves the right, in consultation with the partners, to organise a digital version instead.

## Payment conditions

Payment should be made in one lump sum upon receipt of the invoice regarding registration. The payment term is 30 days from invoice date. If registration is made less than 30 days before Credit Expo, the amount due must be paid simultaneously with the submission of the application for registration.

## Applicable law

Dutch law applies to all agreements and any resulting agreements. All disputes shall be settled by the competent Dutch court.
